- B. 2022-019 – Presentation of Medals of Bravery and Unit Citations from 2021 Monsoon Season.**

- Rincon Valley Fire District conferred some extraordinary honors tonight for some of our extraordinary firefighters.

During 2021 Monsoon Season, our folks effected more swift-water rescues during this period, than what we have done in the aggregate of the last 8 seasons. Some of the rescues were truly lifesaving and our folks performed above and beyond.

Three particular rescues were recognized. Two rescues resulted with four firefighters receiving five Medals of Bravery. These four individuals entered dangerous water in order to save lives. One individual will receive two Medals of Bravery since he was involved in two life or death rescues. They were willing to trade their life for another.

Rincon Valley Fire District also awarded unit citations for these three incidents. In each of these incidents the team worked together to effect the rescue. Their contributions were also extraordinary.


