Dear Resident,

As a public fire agency, we continually assess risk in our community and improve services accordingly. One of our top priorities is to make sure that every property in the Rincon Valley Fire District is incorporated into our service area. As a recognized Fire District in Arizona, membership into the Rincon Valley Fire District is done by annexing a property into our jurisdiction and paying local fire taxes through the assessor's office.

We are proud to bring our ISO Class 2 services to your area, including fire suppression, ambulatory care, and community risk reduction. This Class 2 rating is a Public Protection Classification that places Rincon Valley Fire District in the top 4% of departments nationally, and may help to lower your home insurance premiums.

Next steps

We'd like to ensure these services are available to you. In Arizona, Fire Districts are special taxing districts independent from any town or county government. By joining, you allow the fire district to provide you with emergency services, including timely ambulance response and fire suppression.

If you wish to annex your property, please fill out the attached two-page annexation request and return it to our offices at 14550 E Sands Ranch Rd, Vail, AZ 85641. You can also e-mail or fax it to the contact listed below.

How do I estimate my annual fire district taxes?

Our tax rate is 3.16% of the limited assessed value of your property. Using an average single family residential property in our District:

Limited Assessed: \$20,600 / 100 = \$206

Annual Taxes Due to the District: \$206 * 3.16 = **\$650.96**
